The Government of the Republic of Cabo Verde has received from the International Development Association – IDA/ World Bank (hereafter named “World Bank”), a Credit (hereinafter called “Credit”) toward the costs of the **Resilient Tourism and Blue Economy Development in Cabo Verde Project** and intends to apply part of the proceeds for consulting services. The objective of the Project is to increase diversity and resiliency in the tourism offering and SME participation in tourism-related value chains in targeted destinations.
2. The objective of this Consulting Service (“the Service”) – the objective of this assignment is to hire an urban planning consultancy and design company to draw up the Detailed Plan for Tarrafal de Monte Trigo (PDTMT), as provided for in the Municipal Master Plan (PDM).

 - *Technical and managerial organization of the firm.*

The attention of interested consulting firms is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank’s “Procurement Regulations for IPF Borrowers”, dated September 2023 (“Procurement Regulations”), setting forth the World Bank’s policy on conflict of interest published on the World Bank website.
9. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
10. A consultant will be selected under the **Least Cost Selection (LCS)** method set out in the World Bank’s “Procurement Regulations for IPF Borrowers”, dated September 2023.
