The Government of the Republic of Cabo Verde has received financing from the World Bank toward the cost of the Resilient Tourism and Blue Economy Development Project and intends to apply part of the proceeds toward payments under the contract for **Works of Rehabilitation and modernization of the Mindelo fish market, pier and surrounding area**. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing
2. The *Unidade de Gestão de Projectos Especiais* (UGPE) now invites sealed Bids from eligible Bidders for works associated with the rehabilitation of the **Works of Rehabilitation and modernization of the Mindelo fish market, pier and surrounding area**.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-Procurement in Investment Projects Financing" Sixth Edition - February 2025 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
